3: Myrgan Wood, Barony of -New Order Name *Order of Elders of Myrgan Wood* & New Badge *Argent, an elm tree eradicated proper leaved gules, on a chief vert three garbs Or.*

4: Myrgan Wood, Barony of -New Order Name *Order of Forester of Myrgan Wood* & New Badge *Argent, an elm tree eradicated proper leaved gules, on a chief vert a water bouget argent.*

5: Myrgan Wood, Barony of -New Badge *Argent, an elm tree eradicate proper gules, a chief vert.*

6: Myrgan Wood, Barony of -New Badge *Argent, an elm tree eradicate proper gules, on a chief vert a label dovetailed Or.*

To be associated with the Youth Champion.

7: Myrgan Wood, Barony of -New Badge *Argent, an elm tree eradicated proper leaved gules, on a chief vert two recorders in saltire argent.*

To be associated with the Bardic Champion.

8: Saxa Amelia Africa Na -New Device. *Or, a three-headed dog passant tailed of a serpent's head, a bordure dovetailed sable*

9: Tighearnán Ó Cuinn -New Name.
