Greetings to the Avacal College of Heralds from Arwyn of Leicester, White Wyvern Herald, Kingdom of Avacal Submissions.

The following submissions will be forwarded to Laurel on the Avacal external letter dated 2020-09-21 and were taken from the Avacal KLoI of 2020-08-31.

Forwarded to Laurel Sovereign of Arms:

1: 'A'isha bint Karim - Resub Name and Resub Device, Azure, an Arabic penbox between two bars all between three camels couchant Or.

Forwarded with a minor change from A'isha bin Karim to 'A'isha bint Karim

2: Eirny Halladottir - Resub Device, *Per bend vert and ermine, a bend dancetty sable and in sinister chief a rabbit couchant argent.*

Blazon (words) were changed to reflect a better description of the complex line of the bend.

- 3: Lleucu Llygoden Resub Device, *Per bend sinister purpure and vert, a mouse rampant within an orle argent.*
- 4: Muirenn Inghean Mhic Raith New Name

The following submissions were returned for further work:

1: 'A'isha bint Karim – New Badge, *Or, a brown camel's head couped proper bridled azure maintaining in its mouth a sword inverted argent hilted sable pommeled azure, on a chief wavy azure three crescents argent.*

Was returned for exceeding the complexity count with 9. We have five tinctures, Or, Brown, Azure, Sable, and Argent, 4 charges/elements, Camel head, sword, chief, and crescents. With all the tinctures and charges, we have exceeded the complexity limit of 8.

2: Jadvyga of Samogita – Resub Device, *Quarterly vert and argent, in sinister chief a brown hedgehog proper.*

Was returned because of conflict with Sarra the Lymner's badge (Fieldless) A hedgehog proper. 1 DC for field versus fieldless, but we cannot get a DC for placement on the field against a fieldless badge.

3: Muirenn Inghean Mhic Raith - Per chevron azure and argent, two G-clefs and a trillium counterchanged.

Returned for a redraw because field division is between per chevron and a point.

4: Wolfgang von Sontheim – Resub Device, *Quarterly gules and azure, a wolf passant to sinister and a bordure argent.*

Returned because it is in conflict with Arthur Lacey's device, *Purpure, an Irish Wolfhound courant contourney reguardant gorged of a lace ruff within a bordure argent.* 1 DC for the field. Nothing for type of canine, passant versus courant, head position, or the ruff.
